5.2. Special hazards arising from the substance or mixture

Exposure hazards: In combustion emits toxic fumes. Carbon oxides. Nitrogen oxides (NOx). Hydrogen bromide (HBr).

5.3. Advice for fire-fighters

Advice for fire-fighters: Wear self-contained breathing apparatus. Wear protective clothing to prevent contact with skin and eyes.
