4.1. Description of first aid measures

5.2. Special hazards arising from the substance or mixture

Exposure hazards: In combustion emits toxic fumes. Carbon oxides. Nitrogen oxides (NOx). Borane/boron oxides.

5.3. Advice for fire-fighters
