Vanadium compounds act chiefly as an irritant to the eyes and respiratory tract. Exposure may cause conjunctivitis, rhinitis and reversible irritation of the respiratory tract. More severe cases may cause bronchitis, bronchospasms and astimal like disease. May cause polycythemia, red blood cell destruction and anemia,

albuminuria and hematuria, gastrointestinal disorders, nervous complaints and severe cough.
