## SECTION 4: First aid measures

### 4.1. Description of first aid measures

Fire hazard : Thermal decomposition generates: Carbon oxides. Hydrogen fluoride.

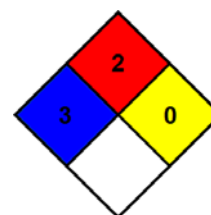
