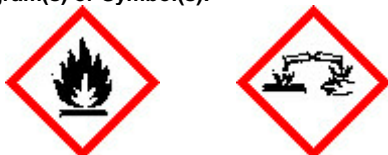

**Precautionary Statement(s):**  
[Prevention]

Do not breathe dusts or mists. Use only outdoors or in a well-ventilated area. Wear protective gloves, protective clothing, eye protection and face protection. Wear eye protection. Wear face protection (full length face shield). Keep away from heat, sparks, open flames or other hot surfaces. - No smoking. Keep container tightly closed. Ground or bond container and receiving equipment. Use explosion-proof electrical, ventilating, lighting, and equipment. Use only non-sparking tools. Take precautionary measures against static discharge. Wear protective gloves, eye protection and face protection. Keep only in original container.

[Response]

If swallowed: Rinse mouth. Do NOT induce vomiting. If on skin (or hair): Take off immediately all contaminated clothing. Rinse skin with water or shower. Wash contaminated clothing before reuse. If inhaled: Remove person to fresh air and keep comfortable for breathing. Immediately call a poison center or doctor. If in eyes: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. In case of fire: Use dry chemical, CO<sub>2</sub>, water spray or alcohol-resistant foam to extinguish. Absorb spillage to prevent material damage.

**4. FIRST-AID MEASURES**

<b>Inhalation:</b>	Immediately call a poison center or doctor. Effects of exposure (inhalation) to substance may be delayed. Move victim to fresh air. Give artificial respiration if victim is not breathing. Administer oxygen if breathing is difficult. Keep victim warm and quiet. Treat symptomatically and supportively. Ensure that medical personnel are aware of the material(s) involved and take precautions to protect themselves.
<b>Skin contact:</b>	For severe burns, immediate medical attention is required. Immediately call a poison center or doctor. Remove and wash contaminated clothing before re-use. Remove and isolate contaminated clothing and shoes. In case of contact with substance, immediately flush skin with running water for at least 20 minutes. Treat symptomatically and supportively. Ensure that medical personnel are aware of the material(s) involved and take precautions to protect themselves.
<b>Eye contact:</b>	IMMEDIATELY flush eyes with running water for at least 15 minutes, keeping eyelids open. Eye contact with vapors or substance may cause severe injury, burns, or death. Call emergency medical service. Move victim to fresh air. Check for and remove any contact lenses. Keep victim warm and quiet. Treat symptomatically and supportively. Effects of exposure to substance may be delayed. Ensure that medical personnel are aware of the material(s) involved and take precautions to protect themselves.
<b>Ingestion:</b>	Do not induce vomiting without medical advice. Call a physician or Poison Control Center immediately. Do not use mouth-to-mouth method if victim ingested the substance; give artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Loosen tight clothing such as a collar, tie, belt or waistband. If a person vomits place them in the recovery position so that vomit will not reenter the mouth and throat. Rinse mouth. Keep victim warm and quiet. Treat symptomatically and supportively. Ensure that medical personnel are aware of the material(s) involved and take precautions to protect themselves.

<b>Acute:</b>	Pain. Redness.
<b>Delayed:</b>	No data available
<b>Immediate medical attention:</b>	WARNING: It might be hazardous to the person providing aid to give mouth-to-mouth respiration, because the inhaled material is corrosive. For severe burns, immediate medical attention is required. If breathing has stopped, perform artificial respiration. Use first aid treatment according to the nature of the injury. Ensure that medical personnel are aware of the material(s) involved and take precautions to protect themselves.

**5. FIRE-FIGHTING MEASURES**

**Suitable extinguishing media:** Dry chemical, CO<sub>2</sub> or water spray. Consult with local fire authorities before attempting large scale fire fighting operations.

**Specific hazards arising from the chemical**

**Hazardous combustion products:** These products include: Carbon oxides Halogenated compounds

**Other specific hazards:** WARNING: Highly toxic HCl gas is produced during combustion.

**Special precautions for fire-fighters:**

Use water spray or fog; do not use straight streams. Dike fire-control water for later disposal; do not scatter the material. CAUTION: All these products have a very low flash point: Use of water spray when fighting fire may be inefficient. Do not use straight streams. Runoff to sewer may create fire or explosion hazard. Containers may explode when heated. Move containers from fire area if you can do it without risk.

**Special protective equipment for fire-fighters:**

Wear positive pressure self-contained breathing apparatus (SCBA). Structural fire fighters' protective clothing provides limited protection in fire situations ONLY; it may not be effective in spill situations. Wear chemical protective clothing which is specifically recommended by the manufacturer. It may provide little or no thermal protection.

**6. ACCIDENTAL RELEASE MEASURES**

<b>Personal precautions:</b>	Avoid contact with skin, eyes, and clothing. Keep people away from and upwind of spill/leak. Use spark-proof tools and explosion-proof equipment. Remove all sources of ignition. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing (Section 8). Warn unnecessary personnel to move away. Stop leak if you can do it without risk. Ensure adequate ventilation. Isolate the hazard area and deny entry to unnecessary and unprotected personnel.
<b>Personal protective equipment:</b>	Wear eye protection (splash goggles) and face protection (full length face shield). Lab coat. Vapor respirator. Be sure to use a MSHA/NIOSH approved respirator or equivalent. Wear protective gloves (nitrile).
<b>Emergency procedures:</b>	Isolate area until gas has dispersed. In case of a spill and/or a leak, always shut off any sources of ignition, ventilate the area, and exercise caution. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Warn personnel to move away. Prevent entry into sewers, basements or confined areas; dike if needed.

**Methods and materials for containment and cleaning up:**

ELIMINATE all ignition sources (no smoking, flares, sparks, or flames in immediate area). All equipment used when handling the product must be grounded. Stop leak if without risk. Ventilate the area. Absorb with an inert material and put the spilled material in an appropriate waste disposal container. Use clean non-sparking tools to collect absorbed material.

**Environmental precautions:**

Prevent further leakage or spillage if safe to do so. Water runoff can cause environmental damage. Prevent entry into sewers, basements or confined areas; dike if needed.

**7. HANDLING AND STORAGE**

<b>Precautions for safe handling:</b>	Do NOT breath gas, fumes, vapor, or spray. Manipulate under an adequate fume hood. Avoid contact with skin and eyes. Keep away from heat and sources of ignition. Use explosion-proof equipment. Use only non-sparking hand tool when handling this product. Ground all equipment containing material. Take measures to prevent build up of electrostatic charge. May corrode metallic surfaces. Good general ventilation should be sufficient to control airborne levels. Keep container dry. Handle and open container with care. Wear suitable protective clothing, gloves and eye/face protection. When using do not eat, drink, or smoke. Keep away from sources of ignition.
<b>Conditions for safe storage:</b>	Keep containers tightly closed in a cool, well-ventilated place. Keep away from sources of ignition. Store and use away from heat, sparks, open flame, or any other ignition source. Store in corrosive resistant container with a resistant inner liner. Store locked up. Keep away from incompatibles. Containers which are opened must be carefully resealed and kept upright to prevent leakage. Avoid prolonged storage periods. Store under inert gas (e.g. Argon). Moisture sensitive.
